THE SHOW

GENERAL RULES AND REGULATIONS

Clash for Cash, a California Nonprofit Public Benefit Corporation, d/b/a THE SHOW (“THE SHOW”), recognized as an exempt 501(c)(3) by the IRS, is organized for charitable and educational purposes and as such may promote and maintain educational functions. Likewise the purpose of THE SHOW shall be to encourage and promote the educational aspects of livestock projects conducted by junior exhibitors.

Force Majeure

THE SHOW shall not be liable for any delay or failure to perform its operations, activities, shows and events to the extent such delay or failure results from a force majeure occurrence. A force majeure occurrence is defined as any occurrence which makes performance by THE SHOW illegal, impossible, inadvisable or, in THE SHOW’s reasonable opinion, unsafe or commercially impracticable, and includes, but is not limited to (i) any breakage or accident to equipment, machinery or facilities; (ii) any strikes, lock-outs or other labor difficulties; (iii) statutes, ordinances, regulations, orders, directives or rules issued by governmental authorities, including, but not limited to those concerning public health and safety, animal disease prevention, detection and response and/or protection of the environment; (iv) judicial decrees or orders; (v) pandemics, epidemics, quarantines, recognized health threats as determined by the World Health Organization, the Centers for Disease Control and Prevention or state or local government authority or health agencies (including, but not limited to the health threats of COVID-19, H1N1 or other infectious diseases); (vi) animal diseases and/or quarantines; (vii) wars, riots or insurrections; (viii) civil disobediences, public demonstrations or sabotage; (ix) acts of God , fires, floods, national disasters, explosions or inclement weather; (x) inability to obtain necessary labor, materials, supplies, utilities or transportation; (xi) depressions, recessions or other economic downturns; (xii) embargoes or energy shortages; or (xiii) any other cause beyond THE SHOW’s reasonable control.

Nugget Casino Resort Emergency Evacuations

During such times as deemed necessary by local, state or federal authorities, the Nugget Casino Resort, THE SHOW, and/or their respective officials may evacuate the Nugget Casino Resort. Incidents such as, but not limited to, bomb threats, acts of war, declarations of war, code red of the Homeland Security System, fire, etc. will be acted upon in accordance and cooperation with local, state and federal authorities. Priority evacuation will be given to human life, then livestock. In such cases, exhibitors and/or contestants will turn over the care of their livestock or equine to the Nugget Casino Resort and/or THE SHOW, as allowed by local, state, and federal authorities. Proper animal husbandry practices will be followed within reasonable expectations until such time the evacuation notice is lifted; then exhibitors/contestants will be allowed to reenter the Nugget Casino Resort and claim their livestock. By making entry into THE SHOW you authorize the Nugget Casino Resort, THE SHOW and their respective officials to detain your livestock on the premises. Furthermore, you agree to hold harmless and without liability the Nugget Casino Resort, THE SHOW, and their respective officials, directors, officers, employees, volunteers and staff for those animals under the reasonable care of the Nugget Casino Resort and/or THE SHOW pursuant to this Paragraph.

Administration of Rules and Regulations

THE SHOW reserves to its Executive Committee the final and absolute right to interpret these rules and regulations and to arbitrarily settle and determine all matters, questions and differences in regard thereto, or otherwise arising out of or connected with or incident to THE SHOW, and the right to amend or add to these rules as its judgment may determine at any time. An exhibitor who violates any of the following rules will forfeit all privileges and premiums. Severability – If any of the rules, or any provision of any single rule, is at any point held to be legally invalid or otherwise unenforceable, all other rules, and all other provisions and terms of any rule containing a provision or term later held to be legally invalid or unenforceable, shall remain in full force and effect.

Disclaimer of Warranties

THE SHOW expressly disclaims any express or implied warranties (including merchantability), whether the goods or services are provided by THE SHOW or by others (such as residue/drug testing). THE SHOW does NOT provide security or guard services and shall not be deemed to be responsible for the security of any personal property or livestock.

Attention: Use of Drugs

The use by non-veterinarians* of animal drugs or other substances in any manner other than in accord with the labeling approved by FDA is a violation of federal law. Exhibitor and exhibitor's parents and/or guardians agree that: (1) they are absolutely and completely responsible persons for the care and custody of their animals, (2) THE SHOW shall be entitled to disqualify an exhibitor whose animal tests positive for any drug, even if the exhibitor and the exhibitor's parents or guardians are innocent of any wrongdoing and did not administer the drug, (3) the drug test results of the testing laboratories are final and binding upon the exhibitor and the exhibitor's parents and/or guardians. Even if the source of the drug is unknown, THE SHOW shall be entitled to disqualify the exhibitor and withhold any premiums or awards.

*** Abuse of the extra-label privilege by veterinarians is unethical and is subject to serious consequences such as license revocation.**

Statement of Liability

All exhibits are under the control and direction of THE SHOW, but THE SHOW is not responsible for any loss or damage that may occur. Each exhibitor and that and exhibitor's parents and/or guardians are solely responsible for any consequential or other loss, injury or damage done to, or occasioned by, or arising from, any animal or article exhibited by him and for its description as given in the catalog, and shall indemnify THE SHOW against all legal or other proceedings in regard thereto, as well as damage or injury to any other person or property, caused by the exhibitor, or any of the animals exhibited by him, or arising out of, or in any way connected with such exhibition of any of the animals so exhibited.

COVID-19

Exhibitors and family members are asked to refrain from attending THE SHOW if they have been in contact with anyone exhibiting COVID-19 symptoms within the 14 days prior to THE SHOW, have a fever or other symptoms, or if you fall into a high-risk category as defined by the Centers for Disease Control. By exhibiting at or attending THE SHOW, you acknowledge that an inherent risk of exposure to COVID-19 exists in any public place where people are present. By attending THE SHOW, you and any guests voluntarily assume all risks related to exposure to COVID-19 and agree to not hold the Nugget Casino Resort, THE SHOW, or any of their

respective officials, directors, officers, employees, volunteers and staff liable for any illness or injury.

Relevant Acts

The United States Department of Agriculture Wholesome Meat Act and the Food and Drug Administration Federal Food, Drug, and Cosmetic Act apply to the sale of market livestock exhibited at and sold during/through THE SHOW.

Internal Revenue Service Form W-9

THE SHOW is required to report payments of \$600 or more to the Internal Revenue Service (“IRS”). Each exhibitor must complete an IRS Form W-9 prior to disbursement of any award or premium monies.

Voluntary Waiver

Each exhibitor agrees that the interpretation and enforcement of these Rules & Regulations by THE SHOW shall be final, without further complaint, appeal, claim, lawsuit or other recourse against THE SHOW. By submitting application for entry, all exhibitors waive any right to challenge THE SHOW’s determinations in that regard

Dispute Resolution

All claims and disputes arising under or relating to these General Rules and Regulations or from participation in THE SHOW are to be settled by binding arbitration in the state of Nevada, County of Washoe, or another location mutually agreeable to the parties. The arbitration shall be conducted on a confidential basis pursuant to the Commercial Arbitration Rules of the American Arbitration Association. Any decision or award as a result of any such arbitration proceeding shall be in writing and shall provide an explanation for all conclusions of law and fact and shall include the assessment of costs, expenses, and reasonable attorneys' fees. Any such arbitration shall be conducted by an arbitrator experienced in Food and Drug Administration (FDA) and/or United States Department of Agriculture (USDA) regulations, specifically the Federal Food, Drug, and Cosmetic Act and/or the Wholesome Meat Act, and shall include a written record of the arbitration hearing. The parties reserve the right to object to any individual who shall be employed by or affiliated with a competing organization or entity. An award of arbitration may be confirmed in a court of competent jurisdiction.

Terminology

For the purposes of these General Rules and Regulations, any reference to he, she, him, her, etc., shall be deemed gender neutral and shall also refer to the opposite gender, in both the singular and plural forms. Likewise, “Executive Committee” and “Show Management” may be used interchangeably.

Entry Requirements and Procedures

1. **Liability Statement:** Exhibitor (and exhibitor’s parent or legal guardian, if exhibitor is a minor) must sign a statement acknowledging that he/she understands and will abide by the liability requirements and rules and regulations of THE SHOW. If the exhibitor does not sign this statement (attached to the entry application), his/her entry will not be accepted.
2. **Entry Eligibility:**
 - a. **Invitational Show:** THE SHOW is an invitational livestock show. The Executive Committee of THE SHOW reserves the right to extend, withhold, or revoke an

invitation to any Exhibitor or Contestant in the sole discretion of the Executive Committee.

- b. **Special Rules:** To be eligible to enter, all livestock must have been raised by a Breeder-Sponsor of THE SHOW and be identified with an official USDA Scrapie Eradication Program Identification tag from a Breeder-Sponsor of THE SHOW.
 - c. **Possession of Livestock:** Animals must be the legal property of the exhibitor or their legal guardian.
3. **Ineligible to Enter:**
- a. **Disqualified Exhibitors:** THE SHOW reserves the right to refuse, withhold, or revoke entry of any exhibitor.
 - b. **Diseased Animals:** Diseased animals cannot enter the Livestock Show area or grounds. Show Management will refuse unloading privileges to animals showing signs and symptoms of disease.
4. **Entry Procedure:**
- a. **Entry Submission:** Entry applications must be submitted electronically on current, official THE SHOW entry applications and must include all requested information. Incomplete entries will be refused and returned to applicants.
 - b. **Acceptance of Entry:** The Executive Committee reserves the right to reject, accept or accept conditionally any application for entry. Entry does not guarantee space in the exhibition building. Entries received after all pens have been reserved or assigned will be required to stall off of trailers.
 - c. **Double Entry:** Animals may be double- or triple-entered in the Jackpot Show, Market Lamb Show, and the Breeding Ewe Show, however, such entry will be expected to comply with all rules of all entered shows (e.g. Market Lamb Show is terminal) once weigh cards are submitted.
5. **Erroneous Entries:** At the discretion of Show Management, exhibits that have been erroneously entered may be transferred to their proper classes prior to judging. Show Management will decide the disposition of each case of erroneous entry upon its merits.
6. **Entry Deadline Dates:** Entry Deadlines are strictly enforced. Entries must be submitted ONLINE pursuant to the entry deadlines as published by THE SHOW.
7. **Refunds:** There will be no entry fee refunds except at the discretion of the Executive Committee, however, if THE SHOW is cancelled for any reason, entry fees will be refunded by the date specified herein for the payment of premiums.

Competition

8. **Judges:**
- a. **Selection of Judges:** The Executive Committee is solely responsible for selecting judges and determining judging systems. Judges will be familiar with all rules, regulations, and procedures of THE SHOW.
 - b. **Judges' Decision:** The judges' decisions are final. If fraud, misrepresentation, error or collusion is discovered after awards have been given, a referee appointed by the Executive Committee will make a decision regarding final placement. Such decisions may be appealed to the Executive Committee from whose decision there will be no appeal. Protests alleging that the judges overlooked exhibits will not be considered.
 - c. **Interfering with Judges:** Any exhibitor or his/her representative, including but not limited to parents, guardians or fitters, who interferes with or displays disrespect to a judge or THE SHOW may forfeit any prizes or monies earned or

be subject to disqualification or other penalties assessed by the Executive Committee.

9. Security Personnel: Exhibitors not cooperating with security personnel of the Nugget Casino Resort or Show Management in all matters of policy, including parking, will have their entries cancelled and will be ordered to remove their exhibits from the grounds immediately.

10. Protests:

- a. **Protest Filing:** All protests must be in writing and be accompanied by a \$2,500 cash deposit, for which a receipt will be issued, which will not be returned if said protest is not sustained by the Executive Committee. The protest must state plainly the cause of complaint or appeal and must be delivered to a member of the Executive Committee immediately after the occasion that prompted the protest. Protests will be accepted prior to, during and within 2 hours immediately following the occasion that prompted the protest.
- b. **Protest Investigation:** Judging procedures will not be interrupted for protest investigation. Depending on the basis of the protest, a decision may be withheld until a complete investigation has been conducted.

11. Show Ring Competition:

- a. **Requirement to Show:** Animals properly entered in a show class must be brought into the show ring for competition. Exhibitors who refuse, without Show Management approval, to lead their animals for parade or for competition in the show ring will forfeit any prizes or monies previously won. Also, refusing exhibitors may be barred from further participation in THE SHOW.
- b. **Arena Promptness:** Promptness to the show ring is required. In order to keep the shows moving, neither classes nor division, breed or overall drives shall be required to wait on an exhibitor to bring their animal to the ring. Show Management has the authority to disqualify an animal if they do not enter the ring in a timely manner.
- c. **Show Ring Assistance:** Exhibitors are permitted to have another exhibitor of THE SHOW assist in the show ring if so desired.
- d. **Disqualification:** If an animal is disqualified after having won awards or premiums, the animals placing below such disqualified animal will NOT be moved up to fill the vacated position and any prizes or monies awarded to such position shall be forfeited and shall be released to THE SHOW to be used as otherwise deemed appropriate by the Executive Committee.

12. Photographs: Exhibitors must present themselves and their animals, at THE SHOW's request, for official photographs. Those photographs are the property of THE SHOW. Unofficial (i.e. personal) photographs may not be published without written approval of THE SHOW. Exhibitors wishing to purchase photographs must contact the Official Livestock Photographer.

13. Media Use of Likeness: By participating in THE SHOW, you consent to your voice, name, and/or likeness being used, without compensation, in any and all media or for any other purposes by THE SHOW and its representatives. You hereby hold harmless and release and forever discharge THE SHOW from all claims and demands related to the use of your voice, name and/or likeness.

14. Removal of Animals: Show Management can remove any exhibit or animal, they deem unsuitable or objectionable, without furnishing reasons for the action. The decision of Show Management is final and exhibitor has no recourse.

15. Animal Welfare: It is the responsibility of all exhibitors to provide proper and humane care and treatment to animals. Show Management reserves the right to disqualify and remove any exhibitor deemed to be in violation of this basic principle of animal husbandry at the

discretion of Show Management. The decision of Show Management is final and exhibitor has no recourse.

16. Animal/Exhibitor Disqualification: To foster fair competition, to provide a level playing field and to protect the safety of food, the showing of unethically fitted livestock and/or animals being administered unapproved drugs is strictly prohibited. Additionally, any animal that has been administered a drug that is FDA approved for its species is subject to disqualification if that animal tests positive for that drug upon arrival at the Nugget Casino Resort in excess of allowable tolerances as prescribed by the FDA for slaughter animals including animals that may be destined for human consumption. All animals must remain free and clear of all drug and chemical residues while on the grounds in excess of such FDA-prescribed allowable tolerances. Any exhibitor found in violation of THE SHOW unethical fitting and/or residue avoidance policy herein is subject to disqualification, forfeiture of premiums and awards, and suspension from future participation in any THE SHOW sanctioned competition.

- a. **Unethical Fitting:** Unethical fitting means any attempt to alter the natural appearance, conformation, musculature or weight of an animal by any unnatural means. Animals showing any signs of being unethically fitted may be disqualified. Examples of unethical fitting include, but are not limited to the following:
 - i. application of any substance to any part of the animal's body, unless specifically allowed in the department rules of that species; injection, drenching or application of any substance per rectum is prohibited;
 - ii. use of injections;
 - iii. draining of fluids;
 - iv. bruising;
 - v. feeding of material not conducive to the health of the animal, safety of food or marketability of its carcass;
 - vi. surgical alterations;
 - vii. artificially filling animals by stomach pumping or airing injections; and
 - viii. Alternative treatments including but not limited to acupuncture.
- b. **Drenching:** The use of drench guns/syringes is allowed. Stomach pumping, drenching tubes or any other method by esophagus more invasive than the use of drench guns/syringes is strictly prohibited.
- c. **Therapeutic Practices:** The practice or use of therapeutic treatments is allowed, including but not limited to animal chiropractic services, massage therapy, electromagnetic therapy, cold laser therapy. Notwithstanding the foregoing, the Executive Committee may disallow any therapeutic treatment or any specific application any therapeutic treatment which the Executive Committee deems objectionable.
- d. **Unapproved Drug Use:** The showing of any animal that has been administered during its life any quantity of any unapproved drug, chemical or medication is strictly prohibited. Such drugs include, but are not limited to, any diuretic, unapproved growth stimulant or other unapproved medication. Unapproved means not approved by the Food and Drug Administration (FDA) and/or the U.S. Department of Agriculture (USDA) for slaughter animals including animals that may be destined for human consumption. Animals must remain free and clear of all unapproved drug and chemical residues while on show grounds.
- e. **Approved Drug Use:** If an animal has been administered a drug that is FDA approved for its species, sufficient time must have passed so that the animal does not test positive for that drug upon arrival at the Nugget Casino Resort in quantities exceeding the allowable tolerances as prescribed by the FDA for

slaughter animals including animals that may be destined for human consumption.

- f. **Animal Inspection:** As condition for participation in THE SHOW, each exhibitor agrees to submit any animal entered by the exhibitor for inspection. Each exhibitor agrees to have such animal submitted to any tests requested by THE SHOW. Each exhibitor also agrees that the opinion reached by the Executive Committee as to whether an animal is unethically fitted shall be final and binding without recourse against THE SHOW or any of its officials, directors, officers, employees, volunteers and staff. Further, the Show specifically reserves the right to have tissue, blood, urine, wool, hair, and/or fecal laboratory analysis made on any animal entered for competition. Any tissue, blood, uring, wool, hair, and/or fecal samples which are collected become sole and exclusive property of THE SHOW at the time of collection. The conclusions reached by the laboratory shall be final and binding without recourse against the Show or any of its officials, directors, officers, employees, volunteers and staff. An exhibitor of an animal that is found to be unethically fitted, and/or testing positive for any unapproved drug, chemical or medication, and/or for any FDA approved drug or medication in excess of allowable tolerances as prescribed by the FDA for slaughter animals including animals that may be destined for human consumption is subject to disqualification, forfeiture of premiums and awards, and suspension from future participation in any THE SHOW sanctioned competition.
 - g. **Non-adherence to Rules:** Any exhibitor or his/her representative, including but not limited to parents, guardians or fitters, found guilty of misrepresentation or not abiding by THE SHOW rules will be disqualified and denied the privilege of showing in THE SHOW.
 - h. **Emergency Treatment:** If an animal requires emergency treatment while on Show grounds, only a licensed veterinarian will be allowed to administer any drug, chemical or feed additive. An exhibitor may choose a licensed veterinarian other than the Official Show Veterinarian, but the Official Show Veterinarian MUST be notified in advance and he/she MUST be present. Animals which are administered treatments with a withdrawal or extended elimination time period will be disqualified from competition. Furthermore, the Official Show Veterinarian, in agreement with the Executive Committee, reserves the right to treat any animal if, in the opinion of the Official Show Veterinarian, it is in the best interest of the animal's health and well-being to be treated. If the Official Show Veterinarian administers treatment to an animal and therefore uses any medication that does not meet the appropriate withdrawal and/or elimination time, the animal will be determined ineligible for competition. Any and all emergency treatment costs are the responsibility of the exhibitor. Any animals receiving treatment under this paragraph which are disqualified from competition as a result of such treatment will be released from slaughter and the exhibitor must remove such animals from the grounds at the conclusion of THE SHOW.
- 17. Animal Handling Devices:** Show Management and/or ring stewards reserve the right to decide what constitutes acceptable show equipment and how the equipment is being used by the exhibitor.
- 18. Arrival Times:** Arrival times shall be determined by Show Management and released on a schedule indicating such. An earliest arrival time will be stated and no livestock shall be allowed on the grounds earlier than such stated time, absent written consent of the Executive Committee.

19. Release Times: Exhibitors and their animals must remain at the Nugget Casino Resort until animals are released by Show Management. Removal of any animals which are entered in a terminal show shall be grounds for automatic forfeiture of any prizes and monies from the current THE SHOW sanctioned competition and automatic disqualification from any future THE SHOW sanctioned competition. An animal on exhibition may not be removed from the grounds prior to its release time absent written consent of the Executive Committee. Animals entered in a nonterminal show shall be released after the conclusion of such animal's class or division, breed, or overall drive. Any violation of this rule will cause forfeiture of all premiums earned by such exhibitor.

20. Awards: Premium money will be mailed to exhibitors no later than September 30, 2021. It is the responsibility of the exhibitor to contact THE SHOW if they have not received a check by such date. All premium checks are VOID sixty (60) days after issuance and will not be reissued. THE SHOW reserves the right to withhold premium monies in any case in which it appears that the rules herein have not been fully complied with. Premium monies and sale proceeds of exhibited animals may be held by THE SHOW indefinitely pending drug residue testing or any ongoing investigation or legal action.

Exhibitor Conduct and Exhibit Area

21. Care of Property: Exhibitors and those in charge of property or livestock shall care for, guard, protect and preserve the same. THE SHOW will not be held responsible for any loss or damage.

22. Fire Marshal Regulations: Exhibitors are strongly encouraged to bring minimal tack and feed into the Nugget Casino Resort. Exhibitors are only allowed to set up and store feed and tack in designated areas as determined by the Fire Marshal and Show Management. Setting up and storing feed and tack in prohibited areas will not be allowed. Rules will be strictly enforced and Show Management will provide a warning to anyone found to be in violation of these conditions. Any exhibitor who fails to heed the warning will be subject to the penalties outlined in the NV Fire Marshal Code and, at the discretion of Show Management, may be disqualified and removed from the grounds.

23. Exhibitor Code of Ethics: THE SHOW is a family friendly event. As such, an individual's conduct as an exhibitor or patron should be exemplary, and violators are subject to disqualification or removal from the grounds at the discretion of the Nugget Casino Resort management and the Executive Committee.

The consumption, distribution, and service of alcoholic beverages must be in compliance with all Nevada alcoholic beverage laws, which defines the lawful consumption and service of alcohol and prescribes sanctions for violations. THE SHOW is an invitational livestock show. THE SHOW reserves the right to extend, withhold, or revoke an invitation to any Exhibitor.

THE SHOW is a non-profit organization and is precluded from engaging in political activity. Additionally, THE SHOW does not tolerate discriminatory practices. Therefore, any clothing or merchandise, signage and décor and public engagement activities must adhere to THE SHOW's non-political and non-discriminatory practices. Any materials, décor, merchandise, clothing and/or anything visible to the general public must be appropriate for a public audience of all ages, races and ethnicities and may not consist of material that may detract from the general character of THE SHOW. THE SHOW reserves the right to remove any of such signage and decor, merchandise and displays, and end any such activity deemed to detract from the general character of THE SHOW.

24. Equipment: Any equipment brought in to be used on the Show grounds must comply with and be used in compliance with all Federal, State, and Municipal Occupational Safety and Health Regulations. The Executive Committee will determine what equipment is allowed on Show grounds.

25. Bedding: All Exhibitors must bring their own shavings. No straw shall be allowed. THE SHOW will not provide any bedding material.

26. Dogs: Dogs are not allowed on Show grounds because of safety and public health regulations. This rule will be strictly enforced and applies to all exhibitors and their parents/guardians as well as visitors. Exceptions are granted for service dogs that are individually trained to do work or perform tasks for a person with a disability. The task(s) performed by the dog must be directly related to the person's disability. The service animal must remain on a leash or otherwise be under the handler's control while on the Show grounds. To protect the health and well-being of all animals on Show grounds, the exhibitor may be asked to provide current health records, including vaccination records to the Official Show Veterinarian.

27. Companion Animals: Only animals entered in THE SHOW are allowed in the pens located in the Nugget Casino Resort. All other animals must be housed on trailers.

Animal Health

THE SHOW is allowed to impose animal health regulations that are more restrictive than those imposed by the Nevada Department of Agriculture ("NDA"). Specific NDA regulations will supersede THE SHOW requirements if there is a dispute between the two in which THE SHOW rules are less restrictive than NDA regulations. In accordance with the NDA, **THESE REGULATIONS ARE SUBJECT TO CHANGE AT ANY TIME.** THE SHOW considers itself an interstate (accepting entries of livestock from within NV and from other states) show for livestock entries. Exhibitors with livestock originating outside the state of NV are encouraged to contact their state Animal Health officials to confirm specific requirements their state may impose on animals returning from a NV show, if any.

28. Permits and General Health Requirements:

- a. **Nevada Origin Sheep:** No Certificate of Veterinary Inspection ("CVI") required. All animals exhibited must have an official USDA Scrapie Eradication Program Identification from a Breeder-Sponsor.

The top three (3) lambs in each class may be weighed immediately following each class. Any lamb that weighs more than five (5) pounds above its official weight will be disqualified and from further competition and lower placing lambs will be moved up. First and Second place class winners may be re-weighed prior to Breed Champion drives. Should a First or Second place winner weigh out at this time, the animal will retain its placing, but will be ineligible to compete for Breed Champion or Reserve. If the First place class winner weighs out, the Second place class winner will then advance to compete for Breed Champion or Reserve honors, but shall retain the premium for Second place as prescribed herein.
